I have modified the scale of the PDF published maps of all 6 national parks from 1:5000 to 1:25000. (1 mm -> 25 m)
I think that the scale 25000 will suffice the accuracy of 20 metres that for now we are looking for.
There is also a caveat that confirm that the boundary is an approximation of the legal one.

Could you check if something needs to be modified?

If so - could you perhaps provide me with a bit more colour on how they tried to do this? I'm keen to assess whether there's any learnings for us.

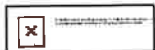
