This Department has reviewed the application and, for the following reasons, is of the opinion that the carrying out of works to remove scrub and bushes in order to allow animals to graze this land. Spot spray weeds within the River Moy Special Area of Conservation (SAC) (SAC-Site Code: 002298). plots on attached map, approx. 2.6 acres of these plots is an activity that comes under the European Communities (Environmental Impact Assessment) (Agriculture) Regulations 2011-2013:

- b. would involve excavations, clearance, habitat loss or alteration, etc.
- c. would be likely to have a significant effect on the SAC in view of its conservation objectives individually, or in combination with other plans or projects, including other on-farm activities, or the possibility of such an effect cannot be excluded
- d. would be likely to have a significant effect on aspects of the environment, including biodiversity, flora, and fauna (including watercourse, lake, surface waters, aquatic habitats/species)
- 2. result in as described in Regulation 3(1) of the Regulations and the proposed activity would also be likely, individually or in combination with other plans or projects, to have a significant effect on a European Site or on a Natural Heritage Area.
