**A.** The minutes from the previous meeting of 10<sup>th</sup> March, 2020 were agreed.

## C. LTMS Engineering Report

Discussion took place on the Engineering Report dated 8<sup>th</sup> April prepared by LTMS regarding the ground stability of the 850 Adit and works undertaken to date. The report identified that while the site is currently stable there is a high risk of instability due to adverse weather like heavy rainfall or extended period of dry weather. Based on the Engineering report the Board discussed the possibility of allowing the works to be re-commenced. The Health and Safety issues were discussed and it was highlighted by Paul that further weakness in the adit could cause instability or the potential for landslides. In the circumstances the Board agreed that the works could be allowed to re-commence. The commencement would be subject to the contractors ensuring that they were compliant with Covid 19 instructions.

Eoin Deegan agreed to issue a letter to the contractors stating that they were essential workers, as per the Covid 19 guidance, until the 5th May 2020, the date for which Governments restrictions are in place. The continuation of the project could then be reviewed in accordance with any new Governments instructions that would be in place at that time.

The following issues were to be followed up on by CDM Smith who are managing the project

The Local residents are to be notified in advance of the re-commencement of the works along with the local/relevant Garda stations to be also informed
