Hi Fintan,

Please find attached a revised proposal for the Kylemore WWTP system.

By way of a recap for us all, I issued a similar proposal to Ann last summer. We received some comments back from Ann/LAWPRO which we responded to which then then lead us to our meeting in August. One of the outcomes of the meeting was that we were to review the possibility of re-introducing Ferric as a dosing chemical rather than the PACI (Alum) proposed in the document prepared by Glan Agua and issued last summer to Ann.

Glan Agua have taken the time to review this for Kylemore quite thoroughly with the attached being their output which suggests Ferric can be used and should result in a vast improvement in the levels of Phosphorous being measured from the outlet of the system. The proposal to also redirect existing septic tanks to the system also being beneficial.

Having the attached proposal and confirmation from Glan Agua that this approach can achieve the desired improvement, I believe is a very positive step for this site. The resumption of ferric dosing can be done so quite swiftly as the infrastructure is already in place with possibly some minor works to optimise the dosing process required. There is also a commitment from Glan Agua to install and manage this dosing system as the competent professionals needed to get the system up and running.

What would be good to understand now is how this proposal might possibly proceed from here. As you have rightly pointed out below, the Appropriate Assessment for the system, with Ferric Dosing was carried out by GCC under 11/1003 which I have also reviewed.

It is noted that a review of the license is the preference of GCC at this time as discussed at our meeting last August. I assume any such review of the licence could take place after the re-introduction of the Ferric dosing and would not prohibit its re-introduction? I imagine any such licence review would benefit greatly from considering a system operating under its intended (and permitted under 11/1003) approach as now set out by Glan Agua.

The licensee will also have the benefit of current data from the programme of monitoring from a system managed by Glan Agua in responding to the licence review.

I am happy to set up a call between us to run through and discuss any of the above as necessary.
