### Hi Stephen,

I note that none of the buildings where bat activity was recorded will be directly impacted by the proposed works. However, the work planned for the adjacent buildings does have some potential to impact on bats if mitigation is not implemented.

I recommend that a derogation issue with conditions attached that restrict artificial lighting to working hours (i.e. no flood-lighting of buildings where bats were recorded after dark) and that ensure that the buildings where bats were recorded are not used to store construction materials, scaffolding etc.

Given the OPW's wider remit for the management of the Phoenix Park and their ongoing efforts to improve the biodiversity of the Park, the proposed works would also seem to provide an opportunity to enhance the roosting potential for bats. I recommend that the OPW be asked to consider this – perhaps this could be by local NPWS staff who might be familiar with the site/involved in providing advice on the works? I also have a contact who I am dealing with about bats in OPW properties and I will mention it to him.
