Many thanks for providing the board minutes and for completing the redactions. Please now find attached a *draft* internal review decision for your review and then issue with your signature.

Prior to finalising the internal review decision, I would be grateful if you would address a few issues/queries that we have identified with the board minutes that were attached to your email. If there is anything we can do to assist on this please let me know.

Numbering

The majority of the minutes are numbered, beginning with No. 12 (Minutes of Meeting dated 20-10-15). While it is clear that this is the first meeting in which the Shot Head Appeal was discussed, it is not apparent why this is numbered "12". Please confirm why some of the minutes are numbered, so that we might consider whether it is necessary to remove the numbering, or alternatively explain the numbering of the documents in the decision-letter. Our concern is that, if one of these actions are not taken, we anticipate that the requester will seek documents 1-11 on further appeal.

Missing Minutes

Your email below omitted the following sets of minutes which minutes were included in the Composite Document we had previously reviewed:

- 47. ALAB Minutes 26-02-20
- 49. ALAB Minutes 22-04-20
- ALAB Minutes 28-05-21

We would be grateful if you would forward us copies of these omitted minutes so that we might consider whether their inclusion is necessary, and if so, what redactions should be applied.

In addition, the Board minutes numbered "57" appear to be missing. However, it is possible that these do not exist and there was simply a misnumbering. In this regard, minutes no 56 are dated 8 October 2020, and minutes no 58 are 5 November 2020. There were no interviewing minutes in the Composite Document previously reviewed. Nevertheless, please confirm if there are a set of Board Minutes numbered "57".

Minutes not to be released

The requester has sought access to copies of all board minutes in which the Shot Head Determination was discussed. We understand from a review of the Board Minutes provided in your email below and in the Composite Document previously released to this requester, that the following minutes are not relevant to this request:

- 31. ALAB Minutes 05-06-18: The Determination was not discussed at this meeting and it did not form part of the composite document. Accordingly, these minutes need not be provided to the requester.
- 42. ALAB Minutes 26-08-2019: Again, these minutes do not discuss the Determination and did not form part of the Composite Document. Accordingly, these do not need to be released to the requester.
- All further minutes recorded after the Board Meeting of **24 June 2021**: The Board Minutes relating to meetings that took place after the Determination (29 June 2021) so far as we are aware did not form part of the Composite Document released and should not be provided on the foot of this request.

Redactions of Board Minutes

I have attached to this email a final version of the Composite Document, noting which redactions were to be made in respect of each Board Minute extract prior to its release to the requester. These redactions related to legal advice obtained by the Board in the making of the Determination, as well as discussions involving the tendering process.

A number of the redactions that we had identified and suggested be made in to Composite Document were not made in the Board Minutes provided in your below email. If the suggested redactions were in fact made, the information that was being protected is still entitled to protection from disclosure at this point in time, and we would advise carrying those redactions over to the Board Minutes being released with the Internal Review Decision. If, on the other hand, the redactions were not made, we cannot now redact the Board Minutes to protect information that the requester already has accesses to.

Therefore, in the first instance, could you please confirm that the redactions identified in the attached document were applied to the Composite Document released to the requester in the first instance.

Subject to the identified reaction having been made, please replicate them in the Board Minutes provided in your below email. For your ease, I have set out which redactions must be made and on what page of each document they can be found:

- (b) any other plans or projects that may, in combination with the plan or project under consideration, adversely affect the integrity of a European Site,
- (c) any supplemental information furnished in relation to any such report or statement,
- (d) if appropriate, any additional information sought by ALAB and furnished by the applicant in relation to a Natura Impact Statement,
- (e) any information or advice obtained by ALAB,
- (f) if appropriate, any written submissions or observations made to ALAB in relation to the application for consent for proposed development,
- (g) any other relevant information

The Board noted this and agreed that it would examine any submissions or observations along with the accumulated advices and information on these site."

Dear Antoinette.

By way of introduction, my name is Lee Boorman and as you know we are acting on behalf of the Board in matters relating to the decision to issue an aquaculture licence at Shot Head, Bantry Bay (the "Determination"). In connection with this, we have been advising the Board on its responses to various requests for information relating to the Determination that have been received from members of the public.

One such request was made by Mr Billy Smyth, Chairman of Galway Bay Against Salmon Cages, under the European Communities (Access to Information on the Environment) Regulations 2007 to 2018 (the "Regulations"). This request was received on 12 September 2021 and sought, among other things, access to "all minutes of ALAB board meetings at which the Shot Head, Bantry Bay salmon farm licence was discussed". By response, the attached letter was issued to Mr Smyth on 20 September 2021, outlining the decision of Mary O'Hara and enclosing a document containing the minutes of Board Meetings where the Determination was discussed. These minutes were redacted in accordance with the provisions of the Regulations, and those redactions were explained in the decision-letter.

The Regulations create a mechanism whereby a requester who is not satisfied with a decision made under the Regulations can seek an internal review of their request. On 12 October 2021, Mr Smyth exercised this right to seek an internal review of the decision of 20 September. In Mr Smyth's email (attached) he indicates that the minutes that he received are incomplete and deficient for the following reasons:

- i. The names of those attending each meeting have not been recorded;
- ii. There was no indication in the minutes as to whether a vote to grant the licence was recorded;
- iii. If there was a vote, the results of the vote, including how each individual Board Member voted, should be recorded.

Reg 11(2) of the Regulations states that, upon receiving a request for an internal review, the public body shall "designate a person unconnected with the original decision whose rank is the same as, or higher than, that of the original decision-maker" to undertake the review. We have discussed this matter with the Chairperson of the Board and we are in agreement that you can act as the internal review decision maker in this case, having regard to the fact that you are (i) unconnected with the original decision, and (ii) hold the same rank at the original decision maker, Mary O'Hara.

Therefore, please now find attached a draft letter acknowledging Mr Smyth's internal review request. Subject to your views, this can be issued to Mr Smyth by email.

Secondly, a substantive response to the internal review request is due to be issued on Friday, 12 November 2021. To this end, we understand that Mary O'Hara was preparing revised versions of the Board minutes that were previously issued to Mr Smyth, which would provide the requester with the information sought. We would be grateful if you would provide us with these revised minutes so that we might review same and begin drafting a final decision for you to review.
