AND WHEREAS having considered only the proper planning and development of the area including the preservation and improvement of the amenities thereof and regard being had to the provision of the County Development Plan I hereby order that an Enforcement Notice pursuant to section 154 & 155 of the Planning & Development Act, 2000 – 2012 which the Senior Executive Officer is hereby authorised and directed to sign is to be served on **Damien Crinnigan, developer**, requiring him, on receipt of this notice, to:

- a) Within three days of the date of this Enforcement Notice cease the importation of material onto to the site and not re-commence the importation of material onto the site until condition Nos. 1, 6, 12, 13, 25, 28 and 34 of Planning Permission PI Ref. 07/2932 attached to planning permission PI Ref. 07/2932 have been complied with,**



- b) Within three days of the date of this Enforcement Notice cease the use of that part of the local road, the L5019-1, as a haul route between the site entrance and the junction with the Edenderry to Kinnegad road, the R401,
- c) Within two months of the date of this Enforcement Notice comply in full with Conditions Nos. 1, 6, 12, 13, 25, 28 and 34 of Planning Permission Register Ref. 07/2932.
- d) Within two months of the date of this Enforcement Notice comply with the requirements of Conditions Nos. 1, 8, 10, 11, 15, 18, 19, 21, 22, 23, 25, 27, 31, 32, 34, 37, 40 and 41 of quarry registration PI Ref. QR32 issued on the 25/04/07 under section 261 of the Planning & Development Act, 2000.

- a) **Within three days of the date of this Enforcement Notice cease the importation of material onto to the site and not re-commence the importation of material onto the site until condition Nos. 1, 6, 12, 13, 25, 28 and 34 of Planning Permission PI Ref. 07/2932 attached to planning permission PI Ref. 07/2932 have been complied with,**



- b) Within three days of the date of this Enforcement Notice cease the use of that part of the local road, the L5019-1, as a haul route between the site entrance and the junction with the Edenderry to Kinnegad road, the R401,
- c) Within two months of the date of this Enforcement Notice comply in full with Conditions Nos. 1, 6, 12, 13, 25, 28 and 34 of Planning Permission Register Ref. 07/2932.
- d) Within two months of the date of this Enforcement Notice comply with the requirements of Conditions Nos. 1, 8, 10, 11, 15, 18, 19, 21, 22, 23, 25, 27, 31, 32, 34, 37, 40 and 41 of quarry registration PI Ref. QR32 issued on the 25/04/07 under section 261 of the Planning & Development Act, 2000.
