# **Welcome and CELUP Crops Research Programme Overview**

Mr Spink welcomed the Authority to the Crops Research Centre, Carlow. He presented an overview of the Programme which includes crops, environment, horticulture and forestry. He expanded on the current staff resource within each section noting that farm and administrative staff are a key element of support to the Programme. Other metrics presented included: programme income and expenditure, and land-use at Oak Park. Mr Spink addressed the challenges faced by the Tillage sector and highlighted in particular the lack of scale and the high cost of land. Dr. Mullins expanded on the research programme in crop production at Oak Park.

The meeting agreed on the importance of adding value to crops through, for example, increased use as product ingredients rather than animal feed. The Director noted the requirement for additional Forestry staffing if the ambitions of DAFM's new Forestry Strategy were to be realised. It was his intention to include a request for additional forestry staffing in the Workforce Plan that was currently being drafted for submission to DAFM. In response to Ms Byrne regarding the need for more metrics in the horticulture sector, he noted the difficulty in obtaining such information given the concern of producers around providing commercially sensitive information.

The Chairman complimented the Director on the Teagasc exhibit at Bloom and asked that the Authority's comments be passed to the organisers.

The Authority thanked Mr Spink and Dr Mullins for their informative overview and were very impressed by the overall quality of the Crops Programme at Oak Park.

- Huge work completed by advisory and support staff who completed about 40k applications for clients for BISS. He indicated there were concerns in relation to the IT system which will be brought to DAFM's attention. He hoped it will not have resulted in errors given the pressure on staff responding to a tight timeline.
- Teagasc must vacate IDA land rented in Athenry to facilitate the new Dexcomplant. Teagasc is actively seeking an alternative facility for the Newford Herd.
- Approval from DAFM to recruit up to 90 temporary staff in the Teagasc Advisory Service to support work related to supporting clients in the context of the New CAP.
- Ms Ellen Vaughan is the Teagasc/FBD Student of the Year for 2022 and Mr Diarmaid Fitzgerald Overall Winner of the Grassland Farmer of the Year 2022. He congratulated the winners and nominees and thanked FBD and DAFM for their generous sponsorship of the awards.
