Further to your request for information under Section 63(1) of the 19912 Act in relation to six sites in Tipperary I attach a planning report for each of the sites concerned which outlines the Councils response to items 1 a, b, d, and f. I also attach a consolidated report from our environment section which details information with respect to item 1 c and e.

In relation to item 2, the Planning Authority carries out its Enforcement function in line with the legislative requirement of the Planning and Development Act 2000 (as amended) and does not have a specific policy *in respect of peat extraction*.

It is also proposed that the Council will undertake to carry out further inspections of the sites during Q3 2024 to ascertain if there has been any change in circumstance and this will be relayed to the EPA in our response.

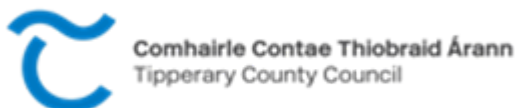
