Dear Save Leitrim,

I refer to the request you made under the European Communities (Access to Information on the Environment) Regulations 2007 to 2018 (S.I. No. 133 of 2007, S.I. No. 662 of 2011, S.I. 615 of 2014 and S.I. No. 309 of 2018) (hereafter referred to as the AIE Regulations) for access to information held by this the Department of Agriculture, Food, and the Marine (DAFM).

**Your AIE Request**

*We wish to receive under the AIE Regulations, in electronic format;*

*With reference to recommendations 17, 18 and 19 of the Project Woodland Regulatory Review (June 2022) (see below)*

*Information related to the development of standard emergency response procedures.*

*To include, but not restricted to, any consultations, actual or proposed, with*

*a) the forestry sector*

*b) other key stakeholders*

*c) prescribed bodies*

*To clarify, this could include any information related to consideration or discussion on the introduction of such procedures and changes to Regulation.*

*There is a very strong public interest case to be made for this information.*

**Summary of Decision**

I have decided on your AIE request on 29<sup>th</sup> January 2054. My decision is to refuse your request.

The basis for my decision is that there are no records received relevant to your request.

## **Search Conducted**

Following the assignment of this AIE request to me I undertook the following searches:

- Searching emails were sent to Linda Morris and Janet Farrell (Forest Policy) for any records or files or documents they held relevant to this AIE. No records were received from either person.
- Searching emails were also sent to Seamus Dunne (Head of Forestry Inspectorate) for any records, files or documents he held in respect of this AIE, no records were received.
- Keywords to be used in the searches were “Project Woodland”, “Review”, “June 2022” and “Emergency response”.

## **Right of Review**

An internal review involves a complete reconsideration of the matter by a member of the staff of this Department, unconnected with the original decision, of the same or higher rank than the original decision-maker, who may affirm, vary or annul the original decision.
