Hi

I would like to report a potential unlicensed forest road in construction adjacent to a sea trout spawning river in Devils Glen, Wicklow

The road is in two parts, with associated drainage into the Vartry river

Coillte have been notified, and say it is not a new road, rather reopening an old road. It has not been a road in the 25 years I have lived next to it. Regardless, it appears as a forest road and it's location will sterilise approx 500m of river bank (trout, kingfisher and otter habitat impacted). There is no obvious buffer that would be in place if this was a forest road. If construction continues with aggregate/drainage, this will expose sea trout spawning beds to predation (human and otherwise).

For context, it used to take me over an hour in waders to access those sea trout spawning pools, now it's 3 mins down the new forest road opened by the digger

In terms of mitigation, I would like DAFM FS to consider

- a) if the Coillte road is an unlicensed forest road
- b) if the contractor has to reinstate the vegetation / block public access to the spawning beds with brash etc
- c) block the drains and install working silt barriers to prevent run off from works into the river
