For the attention of the Minister,

While the weekly dashboard circulated by your department yesterday makes for worrying reading, SEEFA would like to bring attention to a section of the data that signals an urgent need for action.

Afforestation Applications received year-to-date, which, at the time of writing, stands at just **176**. This is approximately half the 345 applications received during the same period last year.

SEEFA believes that the 176 applications received YTD will result in 2026 being the lowest planting rates in the state's history, which we had hoped would be behind us following Minister Hackett's tenure. Our organisation would also like to point out that the 331 applications received in 2024 have subsequently resulted in 1,243 hectares being planted so far in 2025, as per this week's dashboard. Following a similar trend will see afforestation of only around 650 hectares at this stage next year, with only November and December remaining as plantable months due to seasonality.

SEEFA would be happy to arrange a delegation of three members to meet with you and provide a comprehensive briefing on these assumptions. We are eager to work with you to resolve this matter urgently.

SEEFA contacted your department officials in May 2024 to discuss the then-alarming situation, and our group provided workable solutions. During this meeting, SEEFA warned that without meaningful intervention, these numbers would decline further, a prediction that has proven to be true, which is why we are raising it again as a significant concern. To be clear, without serious intervention now, these numbers will continue to decline.

After over a year of engagement with your department officials, our group remains frustrated by the lack of urgency shown. Following our most recent meeting with

your officials last Friday, some of our members were so despondent afterwards that they suggested it would be the last such meeting they would attend.

Not one agenda item presented by SEEFA on May 31st 2024, has progressed beyond the initial discussion stage. It can't be claimed at this point that the decline in applications and lack of interest was not foreseen or advised on. As over 90% of registered foresters actively involved in afforestation are members of SEEFA, it would be remiss of our group not to notify you that enquiries are dwindling, foresters' phones are not ringing, and afforestation is clearly heading towards the worst-case scenario.

What gets measured gets done, and in this instance, we suggest the following:

1. Can your department update the Dashboard to enable the direct comparison that we have detailed above, to allow a weekly review of progress?
2. It would also be helpful if your department issued a licensing plan for the remainder of 2025, which could also be included in an updated dashboard to enable comparison against the same period in 2024 and the 2025 licensing plan projections.

SEEFA remain committed to the recovery and growth of our sector and is available to you at any time.
