Hi Colm,

Thanks for the update. I attach photos I took on 20<sup>th</sup> June 2022, which shows recent landfilling and a recently placed steel container on site. We have been advised by the complainant that over the last few days he is importing materials into the site and he is spreading them as they arrive, thus no stockpiles on site.

I suspect he is trying to landfill the flooded haul road to enable removal of some old quarry materials stored to rear of site, alternatively he may intend to fill the whole site, in any case he requires planning permission to fill this site or any part of the site.

I be happy to do joint inspection with Environment Section early next week.

I wish to let you know that the Env Dept have been dealing with this site for quite a while now and don't have concerns about waste being imported according to recent investiggations. We're also aware of ongoing dispute between the operators and their neighbours.

Could you advise as to what evidence you have about them starting to import materials 1 week ago and whether its your own determination or if its just an accusation that there's landfilling ongoing.

I wish to confirm that both myself and John Tynan have spoken to Mr. Crinnigan in recent months and on each occasion reminded him of the requirement to comply with both Planning and Env legislation. From an Env point of winw our bands are tied if he declares Art 27 and brings in inert S&S
