You may wish to include the following text in your reply to Ms. McDonald;

‘DAFM gave consideration to the response received from Leitrim Co. Council engineers in that the licence conditions included a requirement that the Licensee notify the Council prior to the commencement of harvesting operations and that the DAFM be copied by email. This would provide both parties an opportunity to discuss options regarding the haulage of timber from the site. The primary reason the Forestry Appeals committee (FAC) gave for cancelling licence TFL01142825 was due to the setback distance provided to the nearby dwelling house. Felling licence TFL01311526 increased the set back distance from 30m to 60m’

Dear Forestry Support Unit

I request urgent clarification in relation to TFL01311526, given the statutory appeal period.

Please identify the document, assessment note, Inspector's reasoning, condition, map or other record in which DAFM addressed the Roads Authority's statement that the application did not show access/egress to the site, that on inspection there was no access to the forestry, and that no access/egress, loading or haulage of timber was permitted on the L7381-0.

Please also clarify the basis on which the licence was issued to Madge Cooney where the previous licence for this site (cancelled at appeal) was awarded to FTI Investco 1 Limited. In particular, please identify the record confirming the applicant, owner, licence holder and most importantly the party responsible for compliance with access, haulage, public safety, fire-risk and replanting obligations.

This request is made without prejudice to any appeal and does not suspend or extend the appeal period.
